ENTRY INFORMATION

Entries open on Wednesday August 26, 2026 at 12:00 pm CDT. **Entries close at 12:00 PM CDT, Wednesday October 7, 2026**, or when limit is reached, at the Test Secretary's home, after which time entries cannot be accepted, altered, or substituted. Entry is limited to 20 dogs each test. If Entry limit is not met, entries will NOT be accepted the day of the event.

Any COVID regulations for the site will be enforced.

Entry Fees: Each Entry is \$20, payable by Zelle, PayPal or check to **BTCA**. Closing October 7, 2026 at 12:00 PM CDT, or when entry limit is met. No Entries will be accepted by phone, email or fax. BTCA will add a \$35 collection fee to the amount of each returned check.

ELIGIBILITY TO ENTER

These trials are open to Bull Terriers TWELVE (12) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration.

RIBBONS/ROSETTES

The Bull Terrier Club of America will award a 2x8 flat ribbon for all passing scores for each Temperament Test. Rosette awarded for those earning an ATT Title at the event.

PURPOSE OF THIS TEST

The AKC Temperament Test (ATT) is a general temperament test for all breeds and mixed breed dogs that will assess the dog's reaction to a variety of stimuli. These stimuli will be in the following six categories: Social, Auditory, Visual, Tactile (touch), Proprioceptive (motion) and Unexpected Stimuli. The purpose of the ATT is to test for fear, shyness, inability to recover, and lack of cooperation. Desired traits are that the dog will be emotionally stable, inquisitive, appropriately social for its breed, biddable, and demonstrates the ability to recover from a startling situation in a reasonable amount of time. Dogs who show signs of aggression will not pass the test.

TEST AND TITLE INFO

The ATT is a noncompetitive pass-fail test. In a test, a dog must pass 3 test items in each of the six categories (total of 18 test items). These are selected from a list of 24 possible test items. All dogs that pass the ATT twice under two different approved ATT Evaluators may earn the AKC Temperament Test (ATT) Title.

If a dog passes the ATT on two occasions, under two different judges, the owner may apply for the AKC Temperament Test (ATT) suffix title by going online to www.akc.org/akctemptest and submitting the ATT title application along with the Evaluator Score Sheets (one from each of the two required tests) and the required title application fee. Upon verification, the ATT title will be applied to the dog's record and will appear on the dog's AKC title record. The title certificate will be mailed to the dog's primary owner of record.

COLLARS, LEASHES

Dogs may wear Slip Collars (on dead ring), Martingales, or Body Harnesses. Dogs may not wear prong collars, ecollars, head collars, or harnesses that restrict the dog's movement. Leads should be four-to-six-foot leads of fabric or leather. No retractable leads.
